Currently our Year 12 Early Childhood students are studying Reading Strategies for Young Children. This excursion is a compulsory part of their assessment, to implement planned literacy activities with under 8s students. It provides a unique opportunity for the seniors to implement practical strategies around the Early Years theory we have been learning and to gain one-on-one experience as reading mentors. It will enable a different perspective on Early Years groups and provide an invaluable real-life experience, which they will reflect upon and then submit a written piece for their assessment task.

The class will be involved in a rotation of activities to be conducted in the prep rooms, guided by the Worongary State School Prep teachers. Each student has taken part in two weeks of professional development on reading strategies, provided by the Worongary State School literacy coordinator, to prepare them for the program.
