Congratulations. Your child has been selected to attend the 2022 Year 9 Future Leaders Camp. They will attend the Gold Coast Performance Centre for three days and participate in a variety of activities that aim to improve their leadership skills. By attending the camp, your child will become part of the Nerang State High School Future Leaders Program led by the Year 9 Dean of Students.

At this camp, students will engage in a variety of activities including raft building, stand-up paddle boarding, teamwork challenges and leadership skill building. They will also have the opportunity to apply for a junior leadership position. The cost of the camp includes transport to and from the venue, accommodation, meals and all activities. In order to confirm your child's place at this camp, a \$50 deposit is required.
